**Business Wairarapa Office Chair Racing
Rules and Conditions:**

- This event is a fun CHAIR RACE. Competitors must be aware of the needs and rights of the other competitors who are using the course at all times
- Officials will check at registration, and will refuse entry to those who don't comply with safety requirements including not wearing a helmet and flat sports shoes.
- Riders will be issued with a number which must be worn at all times.
- During the event officials reserve the right to withdraw any rider deemed to be overly zealous causing danger to other competitors.
- Competitors must be responsible for the safety themselves and of other competitors. Anyone finding another in need of assistance is to offer it and tell the nearest official who will arrange help.
- Hazards include but are not limited to uneven surfaces, hedging, other competitors, cones, light fittings, parts dislodging from other's chairs
- The competitor is responsible for removing their chair from the course should it break or become unsafe.
- All competitors are to keep to the track and not damage vegetation or other hazards by creating their own course
- Competitors deemed intoxicated will not be allowed to compete
- All competitors take part in this event at their own risk.

WAIVER

Participants acknowledge and agree that:

- a) I am aware of the dangers of Office Chair Racing and the real risk of injury and accept all risks flowing from my participation in Office Chair race.
- b) I am responsible for reading and understanding any written event instructions
- c) I will abide by all event rules and directions issued by the event organisers
- d) Briefings, signage, and course marshals, are a service to me and other competitors but are not a guarantee of safety
- e) Should circumstances require a change of format or categories within the event, I consent to those changes being made by the organisers
- f) As the organisers cannot control every eventuality, I take responsibility for my own safety on this event, I release all persons associated with the event from any claims arising out of my participation
- g) **The owners of Solway Park Copthorne and Business Wairarapa are absolved from any liability in the event of an accident or injury**
- h) If I am involved in an accident, I will not seek to blame or make a claim against the organisers; nor will I assist anyone else in making such a claim
- i) In the event of an accident I consent to receiving any medical treatment the event organiser or medical or paramedical personnel think necessary
- j) I am responsible for the roadworthiness and safety of my office Chair and the security of all other equipment and personal possessions used in connection with this event
